In terms of regular opportunities for mission and discipleship through various communities and groups at St Mary's, **we are currently ministering to over 1,000 people each month!** Most of these people don't yet know Jesus and we have opportunities through Cafe Hope, Christianity Explored, ignite, Connect, Hope Central, English Classes, Saved food, Little Lambs and much more - to bring them nearer to Jesus. This is amazing and also means so many people are serving. It also needs a lot of financial resource to make it happen!

## Keep St Mary's open and active in mission & ministry

**Our doors are open!** We distribute food, offer community, share with those in need, pray with people, gather children and youth, share meals together, study the Bible, teach the faith, worship and pray, feed the hungry, care for creation, train and equip people to serve others... and much more! We are all about Jesus and bringing His gospel.



Expenditure in 2023 included Cafe Hope at £44,000. Nine staff cost £167,000, utilities cost us £35,000. We have had lots of maintenance and repair work across the church site, the total was £51,000. Ministry and mission needs significant financial investment and generosity from the church family.



## Fully meet the everyday costs of being open

People are at the heart of our ministry. We want to keep open and active, sharing the gospel, discipling people and caring for people in Jesus name. In 2024, we are aware of more costs that will come including a new Table Tennis Table for Connect, two new laptops to replace ageing ones, further maintenance of the buildings and much more. We do apply for grants, and we do keep costs to a minimum, but we are aware that staying open and active in ministry is expensive, so we need more Gospel Partners.

# Generous giving is central to our spiritual maturity

Let me encourage you to step out in giving and generosity as part of your Christian walk. We are all called to give according to our ability and when we all give, there will be enough for all God wants to do. It is important that there is equality in that everyone is participating in giving, so we share it together.

We are mindful that all our circumstances are different. There is no pressure and we each need to give as is appropriate for us. If you pay tax at the higher rate you can claim further tax relief in your self-assessment tax return. If you are unsure whether your donations qualify for Gift Aid tax relief, please contact us or ask at your local tax office for leaflet IR65 Gift Aid. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that we reclaim, you can cancel your declaration (see first note above). Please notify us if you change your name or address.
