GIFT DAYS - BIG VISION

Resourcing St Mary's to reach our community

1. Opening our doors to the community with Cafe Hope

We see hundreds of people every week come through the church doors into Cafe Hope. Our heart is to offer a space of hospitality, listening, prayer and sharing Jesus. We employ three staff now and have many volunteers.



2. Reaching those in real need through Living Hope



We have seven main mission focussed projects and communities such as Connect, Hope Supper, Saved food, English Classes and Coffee Club, which reach out and touch the lives of people in most need. We employ two staff now and have lots of volunteers.

3. Investing in our amazing children and youth

We want to keep investing in the next generation of disciples and leaders. We have an amazing team of volunteers, but also one staff member focussing on this area of ministry.



4. Improving our experience of church

There are a number of key upgrades we need to make to our PA system that will improve the quality of sound at the back of church. We also need to purchase a new electronic church piano and replace ageing staff laptops.

5. Maintaining good buildings for mission & hospitality

Our buildings are part of our mission and hospitality. We use them all through the week. Maintenance is part of our mission. We want to offer a good welcome to people. There are some essential upgrades needed. We are also facing a bill of over £6,000 to replace the LED lights in church. This needs to happen within this or next year. We are also aware there is much redecoration work needed in the church sanctuary and across the site.

OUR CHURCH FINANCES

We don't get any financial help from the Church of England. Almost all income comes from our church family. We also apply for all the grants we can.

Some expected costs for 2025: Parish share sent to the Diocese (£102,312); Employing our staff team (£151,644); Utilities (£29,850); Repairs (£18,500); Away Giving (£11,200); Insurance (£5,253). Cafe Hope costs £42,698 to run, although it also has income. Living Hope costs £25,132; Ignite costs £12,809

Our total expenditure for 2025 is expected to be £382,790. We currently expect a budget deficit of £41,000. We cover this with Gift Days and reserves, but these have been decreasing over the past few years.

If you wish to you can cancel the declaration at any time, please notify us. You must pay an amount of income tax and/or capital gains tax at least equal to the tax that we reclaim on your donations in the tax year (currently 25p for each £1 you give). VAT and Council Tax are not included. If you pay tax at the higher rate you can claim further tax relief in your self-assessment tax return. If you are unsure whether your donations qualify for Gift Aid tax relief, please contact us or ask at your local tax office for leaflet IR65 Gift Aid.If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that we reclaim, you can cancel your declaration (see first note above). Please notify us if you change your name or address.
